



REGULATIONS 2025

RIGHT TO FISH

- Access to the lake is by reservation only, by contacting us in advance and returning the booking voucher which will be sent to you after an initial contact by phone or email.
- The 50% deposit is mandatory to book your stay and will not be refunded under any circumstances
- In case of cancellation + 2 months before the scheduled date, the stay may be postponed to a later session of more than 12 months,
- If the cancellation occurs less than 2 months before the arrival date, it will be lost if you do not attend or it can be transferred to a third party.
- No refund, postponement or credit note will be made in case of early departure by the fisherman and/or companion for any reason
- A deposit of €200 will be requested on arrival, will not be charged and will be returned on departure after checking the cleanliness of the station and returning the borrowed material in good condition (mat, landing net, weighing bag)
- Dogs are tolerated on the premises (1 dog per station) and under the full responsibility of the person who has booked. Deposit 50€ + shovel mandatory to present on arrival
- The entrance door to the gravel pit is locked with a coded padlock. We will send you the code upon arrival.
- Door closing is mandatory after each opening

DEPARTURES / ARRIVALS

- **The reception is only open for arrivals and departures as per reservation**
- Departures are at 9 a.m.
- Arrivals at the stations are from 10 a.m. to 12 p.m . for all anglers/companions.
- No departure or arrival outside of the time slots will be allowed, please make your own arrangements.
- It is forbidden to install themselves at the workstations before going to the reception
- No change of position can take place without our permission.

COMPANIONS

- Limit of 2 adults per season (non-anglers),
- "Companion Package" to subscribe to when booking
- Free for children under 18 years old.

VISITS

- Visitors are tolerated on the site, within reason (close family or friends)
- **MAXIMUM 4 VISITORS AT THE SAME TIME** per station, only with the authorization of the managers and after signing a certificate for the use of the life jacket for stations 1 and 2.
- They will have to park their vehicles **OUTSIDE** the enclosure and will have to reach the station on foot
- They will have to get out of the water at 6 p.m. at the latest. Any visitor present without authorization will be forced to leave the site without delay and will result in the payment of the deposit

VEHICLES AND TRAFFIC ON THE PREMISES

- Vehicle traffic around the lake is allowed on arrival and departure from the moorings.
- Vehicles must then be parked in designated spaces
- The maximum speed allowed around the body of water is 20 km/h.

BAIT BOATS & BOATS

- Bait boats and boats are authorized according to the pole boundaries shown on the plan and are marked on the lake by visual markers.
- The boat is allowed in the fishing action. THE USE OF A VEST IS MANDATORY under penalty of immediate confiscation of the vessel. Minors are not allowed on the boat.
- The use of the electric motor is possible, however, only motors offered for rent are allowed to avoid health risks (see price).
- In the event of breakage, loss or damage to the borrowed or rented equipment, the amount of the repairs will be deducted from the deposit.
- All fishermen release SAS AD FISHING - CARPE EXPÉRIENCE from any liability in the event of an accident of any kind and ensure that they waive any action against them.
- No hardwired wire markings allowed, only tube markings allowed.

FISHING

- Fishing with brittle (device attached to trees) is prohibited.
- No swimming
- Carp fishing is done with 3 rods per angler – 4th optional
- One hook per line, single micro-barb hook.
- Authorized hook sizes: from 2 to 6.
- Only one leader per rod!
- Nylon mainline 0.30 mm (30 hundredths) minimum, braid allowed on mainline.
- **Nylon leader MANDATORY between 40/100 and 50/100.**
- Gear should allow the lead to be easily released from the gear in the event of breakage and the fish to come loose in the event of breakage. The strength of the leader must be less than that of the main line.
- **Locked mounting forbidden**
- Anti-tangle cover forbidden
- Leadcore, leader in fluro or banned tungsten, as well as all sleeves serve as anti-tangles (see photo)
- The use of your landing nets, weighing bags and landing mats is prohibited, these accessories are provided on arrival for health reasons.
- Handling of the fish should be done with the utmost care: water the fish thoroughly, kneeling photo shoot (standing with the fish in your hands is prohibited), release the fish immediately after the photo shoot and as soon as possible.
- PROHIBITED STORAGE BAGS (immediate exclusion without refund).
- ALL SEEDS ARE PROHIBITED except sweet com, roasted seeds, and those sold by Carpe experience. (**Off-farm seeds will not be accepted.**)
- Boilie cannons are prohibited.
- Predator fishing is prohibited.
- A pellet rod is tolerated by the angler, but only in NO KILL (no Feeder rod or English rod)
- Prohibited baskets
- **Each fisherman must respect the distances and the fishing area associated with the position he occupies.**
- -Anglers must be present at their post when the lines are in the water.
- If you have to be absent (even at the next station), **please raise your rods.**

- We send one tackle per session, randomly, to all the fishermen, to check that the rules are respected.

GENERAL

- Terrestrial fires are prohibited. Barbecue on the ground is tolerated, the ashes should be emptied into a garbage bag and removed at the end of the session. A full bucket of water, ready to extinguish any overflows, should be nearby when the barbecue is done.
- Stations must be clean at the time of your departure, and all trash must have been picked up and brought in by the end of the session.
- **IT IS FORBIDDEN TO THROW CIGARETTE BUTTS ON LAND OR IN WATER!**
- Hunting and swimming are strictly prohibited on the site.
- Restrooms and sanitary facilities are available on site, please respect them and keep these spaces clean after your visit.
- The felling of trees, shrubs or plants, which damages boats, toilets or other facilities within the lake enclosure is prohibited.
- There are sheep present at the site. It is forbidden to feed and scare them.
- Please respect the surrounding wildlife.
- The night lighting and the noise level of the detectors must be reasonable, so as not to disturb the tranquility of the place and the proper functioning of the session of the other fishermen.
- Appropriate attire is required. Drug use, drunkenness, rioting or a disrespectful attitude towards other fishermen or managers will result in immediate and permanent exclusion without reimbursement of the sums paid, and may eventually lead to legal proceedings.
- All of our fish are listed so we can keep track. Any attempted theft, mutilation, or poaching will result in prosecution.
- For your safety, the site is under 24-hour video surveillance and increased surveillance is carried out in the gravel pit.
- Generators are **FORBIDDEN**

When you book a hornbeam experience, you're booking a stay at a fishing center, not a leisure center. Therefore, you agree to respect the rules, the site and the other anglers.

ANIMALS

- Dogs are tolerated on site (1 dog per station) and under the full responsibility of the person who made the reservation.
 - Deposit 50€ + shovel mandatory to present on arrival
- They should be kept on a leash on posts 1 and 2 due to the presence of sheep and not wander around the other stalls or around the water
- You should not disturb other anglers (barking, aggression, etc.), please pick up their needs and should not harm the animals on the site.
